



HEALTH AND SAFETY AT WORK ACT 2015

- > 04 April 2016
- Act and supporting Regulations
- Responsibilities, Hazard to Risk, Engagement
 Consultation, Cooperation, Coordination
- Work Safe NZIncreased penalties



RESPONSIBILITIES

> PCBU - Primary duty of care

> Officer – Due diligence

Worker – Reasonable care

> All have responsibility; some have multiple



PCBU RESPONSIBILITIES

> To ensure the health and safety of:

- Workers employed/engaged or caused to be employed/engaged by the PCBU
- > Workers whose activities are influenced or directed by the PCBU
- > Other persons in the vicinity of the work

> Primary duty to:

- > Ensure health and safety of workers
- > Provide safe working environment
- > Provide safe plant and systems
- > Ensure the safe use, handling and storage of plant
- > Provide adequate facilities for welfare of workers
- Monitor health and conditions in workplaces



PCBU RESPONSIBILITIES

> Duty to consult, cooperate and coordinate activities

- > with all other responsible persons
- > 'overlapping' duties
- > continuous duty



PCBU RESPONSIBILITIES

- > 'Upstream' duty
 - for design, manufacture, import or supply of plant, substances or structures, it must ensure there are no risks to 'downstream' persons



OFFICER RESPONSIBILITIES

> Due Diligence

- > Keep up to date and understand the nature of hazards and risks associated with the organisations operations
- Ensure the organisation has resources and processes to eliminate or minimise risks
- > Ensure processes for reporting and responding to incidents, hazards and risks.
- > Ensure processes for complying with any duty
- Verify that health and safety processes are in place and being used.



WORKER RESPONSIBILITIES

- > Take reasonable care for own health and safety
- Take reasonable care that own acts/omissions do not adversely affect the health and safety of others
- **Comply** with reasonable instructions from the PCBU
- Cooperate with reasonable health and safety policies and procedures



WORKSAFE – THE REGULATOR

- WorkSafe works collaboratively with businesses, undertakings, workers and their representatives to embed and promote good work health and safety practices. Some of WorkSafe's functions include:
 - > Engaging with industry and duty holders
 - > Educating duty holders about their responsibilities
 - > Enforcing health and safety law.



MAXIMUM PENALTIES

Offence	Individual	PCBU (individual) or Officer	PCBU
Reckless Conduct that exposes to serious injury, illness, or death	5 years \$300 000 or both	5 years \$600 000 or both	\$3 million
Failure to comply that exposes	\$150 000	\$300 000	\$1 500 000
Failure to comply	\$50 000	\$100 000	\$500 000



SCENARIO - THEN

- Base Commander
 - > RNZAF, NZDF, contractors, families, visitors
 - > Duty of care work, work-related, non-work
 - > Prime contractors
 - > Assumed and/or unknown
 - > DOL and/or CAA 'asked' to come on Base



SCENARIO – NOW?

> PCBU

- > RNZAF, NZDF, contractors, families, visitors
- > Primary duty of care
- > Consult, cooperate, coordinate

Officer

- > Due diligence
- Decisions made (up and down)
- In place and being used



SO WHAT RESPONSIBILITIES HAVE CHANGED?

- Messy is still messy
- > Health and Safety is only one dimension
- > Clients need to clarify their own responsibilities

> All responsibilities have changed
