## Safety in Design – Practice Forum

- The Health and Safety by Design team is a new initiative by WorkSafe New Zealand. Dr Dave Moore is the team Lead as of Feb 2020.
- It sits within the WorkSafe Operations Group as part of the Wellington-based Health and Services Technical Team.
- Dave will be based in Auckland though, to have better access to the construction/infrastructure sectors.
- The HSbD team is currently planned to build to a group of 5-6 nationally.
- It will cover all industries.
- Focus of the team.
  - o Upstream responsibilities of parties under the Act.
  - Health as well as Safety. We are ten times more likely to die slowly from our jobs than quickly.
  - o Integration of psychosocial factors into the design of work
- Constraints / challenges include:
  - o A new unit, so relationships and strategies still to be formed.
  - All industries are structurally and culturally different.
  - All nations struggle when tackling occupational health.
- Dave's background.
  - o Trained and worked first for 10 years in architecture. Predominantly in UK.
  - O Did his postgrad studies in Human Factors / Ergonomics.
  - Moved to NZ permanently in 1990.
  - Set up South Pacific Ergonomics Ltd. Consulted across all industry sectors in NZ between 1992 and 2000.
  - Sold business to SCION (Forest Research) and worked in their Human Factors team. Specialising in primary industries.
  - Completed PhD: 'A systems approach to the design and use of quadbikes.' Part funded by ACC and FRST.
  - 2012 2020. AUT Programme Leader for the Master of Engineering Project Management. Also Co-Director of the AUT Centre for Occupational Health and Safety Research.
  - Feb 2020 joined WorkSafe.
- Hoping for: a productive working relationships with the leaders, and subject matter experts
  on the ground, in all the key sectors.
- Next steps. Building networks and developing internal and external plans for the next 24 months.
