#### SW Operations – outcomes so far

- Staff workloads and timeframes challenging
- Developing a single contract and process
- Benchmarking process
- Managing contractor expectations
- Developing a job management system

# SW Operations – outcomes so far

- Harmonised levels of service
- Ability to benchmark across contracts
- Collaboration and knowledge sharing built into contracts
- Ability to reward good performance through award of minor capital projects
- Innovative equipment offered
- Council saving of over \$500k per year.



# Landfills Services

- Aftercare responsibilities for 200 closed landfill sites
- Various monitoring and aftercare contracts with legacy councils
- Seeking consistency, quality and compliance with consent requirements
- Optimise contract management and administration



#### Landfills Services - outcomes

- 3 geographic areas selected
- 2 suppliers chosen 1 consortium
- Price quality methodology used
- Benchmarking component
- Compliance achieved
- Estimated savings of \$250k over a 2 year contract



# **RMA Consent Planning**

- 150 resource consent applications across stormwater per year
- Seeking to increase consistency across suppliers
- Seeking to streamline procurement processes



# **RMA Consent Planning**

- 3 area geographic split
- Also a panel of specialist suppliers
- Incentivised by 1+1 contract
- Benchmarking process
- Encouraging and sharing innovation
- Reduced delivery risk
- Relationships will be built across Council
