



09:05am **The People Piece - Rethinking the primary duty of asset manager, designer and project manager to protect people at all stages of an asset's lifecycle**
Wendi Croft, Director Health, Safety and Wellbeing - Massey University

Imagine if we could reduce our incident rates by 60% or reduce the severity of injuries by 90% simply by changing how we manage our assets or how we approach a new design. Statistics show that we can reduce harm by at least that much through safety in design. But it's not all about infrastructure and construction as has traditionally been the focus in the UK and Australia. And it's not just about meeting existing standards or codes. The new Health and Safety at Work Act 2015 extends the primary duty of care to designers, importers, manufacturers, and suppliers. And the definition of "designer" isn't as narrow as one might think! Wendi Croft, Director Health Safety & Wellbeing from Massey University will explore the intent of the legislation, how it should be interpreted and applied using a wide variety of real life examples and storytelling. In addition, the CCG Safety in Design Steering Group's position will be shared and discussed in depth. The position statement has been recently formed by New Zealand's major clients, consultants and government agencies who are actively working together to establish a consistent understanding and application of safety in design in New Zealand.


